
they prevent unauthorized usage of certifications. With a digital certification badge, one can quickly verify its authenticity and the requirements to obtain it. This

certificates, which cannot be verified instantly.






Share Your TMI Digital Badge on Social Media using Credbadge™


Step 1: Open your web browser and navigate to www.credbadge.com. Once you reach the page, click the "**LOGIN**" button at the top-right corner to proceed.



Step 2: Log in to your Credbadge™ account.




Step 3: Choose where to share your Digital Badge by clicking on the corresponding social media icon.




Upon clicking the respective social media icons on the Credbadge[™], here's what you'll find:

Share Your Digital Badge on X




You will be directed to X, where a window similar to the image above will appear. With just a click on the link, your followers can view your Digital Badge.

Share Your Digital Badge via Email




By simply filling in the email ids as shown, you will be able to share your credentials with potential employers, colleagues, or recruiters who can easily authenticate your digital badge details.

How to Display Your TMI Credential on LinkedIn?

Step-by-Step Instructions

LinkedIn profile features a section called "Add licenses & certifications", designed to display credentials. This is the most suitable place to showcase your TMI credentials.

- **Step 1:** From the home screen, click on your profile.
- **Step 2:** After opening your LinkedIn profile, Select the "**Add profile section**" tab. A pop-up menu will appear with options to be added to your profile.
- **Step 3:** In the "Add Profile Section" window, click on "Recommended", it will give the option to add "licenses & certifications".




Step 4 – Once you click the "Add licenses & certifications" button, LinkedIn will give you a new window to add certification details as appropriate to your status.

In the "Certification Name" field, enter the suitable reference to your status. For example, if you have met the requirements for the GTML™ certification, including passing the GTML™ certification exam, you may enter "Global Talent Management Leader".

In the "Issuing organization" field, enter "Talent Management Institute". Add the "Issue" and "Expiration Date" of your credential. In the "Credential ID" field, enter your unique credential code from your Credbadge™ account.

In "Credential URL" section, fill in the unique URL of Credbadge™ which you can copy from your Credbadge™ account.


Once your entry is complete, click on "Save" button and the credential will be added to your profile. You will find the added credential in "Licenses & Certifications" section in your LinkedIn profile.





Updating your Bio


- Log in to your X account.
- Click on 'Edit profile'.
- Under 'Bio', add details about the credential that you have achieved from TMI.
- To showcase, you can also add your Digital Badge URL in your bio.
- You can also add your TMI designation to the profile section next to your name.



Displaying Your Credential on Your Business Card


- Confirm with your company's branding guidelines if third-party logos are allowed on your business card as many employers do not permit this.
- Verify if your organization permits 4-color printing of business cards. Note that the TMP™, STMP™ or GTML™ logo must be printed in full color, otherwise it cannot be used. If used, the logo should be no smaller than 0.307 inches in width and 0.502 inches in height and the business card size should be 88.9mm x 50.8mm.
- For optimal print quality, please use the .jpg logo file at the size provided or provide the .eps logo file directly to your business card designer/printer.





• If you are not allowed to use any logos on your business card, you can still mention your TMI credential with your name, as indicated below.
